At a regular meeting, held between the first Monday in February and the first Monday in August, the board of education of each local school district, from lists adopted by the county board of education and the board of education of city and exempted village school districts shall determine by a majority vote of all members elected which of such textbooks so filed shall be used in the schools under its control. No textbooks shall be changed, nor any part thereof altered or revised, nor any other textbook substituted therefore, within four years after the date of selection and adoption thereof, as shown by the official records of such boards, except by the consent, at a regular meeting, of four-fifths of all members elected thereto. books so substituted shall be adopted for the full term of four years.
